0.4 ml clear pipette with a film composed of 3 layers: a polypropylene/COC, solventfree lacquer laminate and a copolymer of polyethylene/EVOH/polyethylene. The pipettes are sealed within a child resistant 4-ply foil sachet composed of LDPE/nylon/aluminium foil/polyester film and presented in an outer box. Package Sizes: Pipettes are presented in cardboard boxes containing 42 pipettes. Each pipette is individually sealed in a foil sachet.
