**5. TARGET SPECIES**

Dogs

**6. INDICATIONS**

The collar demonstrates:

- Repelent effect (anti-feeding) during 5 months for sandflies (*Phlebotomus perniciosus*)
- Repelent effect for 6 months for culicid mosquitoes (*Culex pipiens*)

The collar prevents from:

- Tick infestation for 6 months.
- Fleas infestation for 4 months.

It has been proved the repellent efficacy (antifeeding) against *Phlebotomus spp*, so it can be considered as part of the program of prevention for Leishmaniasis and the culex mosquitoes of the complex *Culex pipiens*.
