2. STATEMENT OF ACTIVE SUBSTANCES

One collar of 35 cm (15.90g) contains:

Deltamethrin 0.636 g

3. PHARMACEUTICAL FORM

Medicated collar

5. TARGET SPECIES

Dogs

6. INDICATIONS

The collar demonstrates:

- Repellent effect (anti-feeding) during 5 months for sandflies (*Phlebotomus perniciosus*)
- Repellent effect for 6 months for culicid mosquitoes (*Culex pipiens*)

The collar prevents from:

- Tick infestation for 6 months.
- Fleas infestation for 4 months.

It has been proved the repellent efficacy (antifeeding) against *Phlebotomus spp*, so it can be considered as part of the program of prevention for Leishmaniasis and the culex mosquitoes of the complex *Culex pipiens*.

Fits necks up to 28 cm
Anti-strangulation safety
